If a third party operates outside the EEA although they may not have the same data protection laws as organisations in the UK, we will take steps to make sure that they provide an adequate level of protection. By submitting your personal data to us, you agree to this transfer, storing or processing outside of the EEA.

Storage

We will only store your personal data for as long as necessary to fulfil the purposes of why we collected it, including for the purposes of satisfying any legal, accounting or reporting requirements.
